Chairman's Statement 主席報告

Dear Shareholders,

On behalf of the board (the "**Board**") of directors (the "**Directors**") of the Company, I am pleased to present the annual results of Sanroc International Holdings Limited (the "**Company**") and its subsidiaries (collectively, the "**Group**") for the year ended 31 March 2017 (the "**Year**").

On 10 February 2017 (the "Listing Date"), the Company's shares was successfully listed on the Main Board (the "Main Board") of the Stock Exchange of Hong Kong Limited (the "Stock Exchange") (collectively the "Listing"). The Listing has not only marked a significant milestone for the Group in improving its capital strength for the Group's future business development, it also enhanced a public reputation in the market.

Regarding to the business environment, the slow recovery of the global economy coupled with political filibuster in Hong Kong has unfavored Hong Kong macroeconomic environment and the construction industry. Despite of the challenge facing by the Group, we strive to maintain our competitive position within the market by different business strategies.

The revenue of the Group is approximately HK\$175.9 million for the Year, representing a decrease of approximately 14.4% as compared with the revenue for the year ended 31 March 2016 (the "Previous Year"). The decrease was mainly attributable to the combined effect from the decrease in revenue generated from trading of construction machinery and the increase in revenue contributed by leasing of construction machinery and transportation services. Our Group's net profit for the Year was approximately HK\$17.2 million, representing a decrease of approximately 47.9% when compared with that in the Previous Year. The decrease in net profit was mainly due to the increase of the oneoff listing expenses, staff costs and expenses and depreciation of assets. By excluding one-off listing expenses, our Group's net profit for the Year is approximately HK\$34.4 million, representing a decrease of approximately 2.1% when compared with that in the Previous Year. Details of the Group's business performance for the Year are set out in the section headed "Management Discussion and Analysis".

各位股東:

本人欣然代表善樂國際控股有限公司(「本公 司」)董事(「董事」)會(「董事會」)提呈本公司 及其附屬公司(統稱「本集團」)截至二零一七 年三月三十一日止年度(「本年度」)的年度業 績。

於二零一七年二月十日(「上市日期」),本公司 股份於香港聯合交易所有限公司(「聯交所」)主 板(「主板」)成功上市(統稱「上市」)。上市不 僅標誌著本集團為其日後業務發展而增強其資 本實力的重要里程碑,同時亦提升了在市場上 的公眾聲譽。

營商環境方面,全球經濟復甦步伐緩慢,加上 香港出現政治阻撓,均對香港的宏觀經濟環境 及建築行業造成不利影響。儘管本集團面臨重 重挑戰,我們採取各種業務策略,努力保持我 們在市場上的競爭地位。

本集團於本年度的收益約為175.9百萬港元, 較截至二零一六年三月三十一日止年度(「上一 年度」)的收益減少約14.4%。有關減少主要是 由於來自建築機械貿易的收益減少與建築機械 租賃及運輸服務貢獻的收益增加的綜合影響所 致。本集團於本年度的純利約為17.2百萬港 元,較上一年度減少約47.9%。純利減少主要 是由於一次性上市開支、員工成本及開支以及 資產折舊增加所致。若不計一次性上市開支, 本集團於本年度的純利則約為34.4百萬港元, 較上一年度減少約2.1%。本集團於本年度的 業務表現詳情載於「管理層討論及分析」一節。

BUSINESS REVIEW AND MARKET PROSPECT

Our Group provides construction machinery trading and leasing services in Hong Kong. Our business includes: (i) trading of construction machinery, which are mainly foundation machinery and drilling accessories; (ii) leasing of construction machinery, which are mainly power and energy machinery; and (iii) the provision of local transportation services with our crane lorries.

As the global economy has experienced slow recovery, the demand for construction projects has greatly contracted which also led to the contraction of the construction machinery manufacturing industry and excessive production. Hong Kong, being one of the international cities in the world, has undoubtedly been impacted by the macroeconomic environment. Besides, the construction industry in Hong Kong has been affected by political filibuster, resulting in delay of a number of construction projects.

Nevertheless, the Ten Major Infrastructure have significantly stimulated the Hong Kong construction market. It is projected that a number of new projects such as the public and private housing plan and the construction of a new runway at the airport will be put into practice in the following years with the Hong Kong government's support as a part of infrastructure plan. With the increase in demand of construction projects in the long run, contractors are likely to maintain a machinery fleet to ensure efficient operation. As such, we believe that the commencement of the construction projects coupled with our competitive strength maintained in the market would lead to the growing demand by our customers for contribution to our revenue as a result.

In addition, we have a leasing fleet of over 600 units of power and energy machinery as at 31 March 2017, including a wide range of selection of power generators and air compressors of different models and standards. As planned, we continue to expand our leasing fleet to maintain our strength on our principal type of machinery, namely power and energy machinery, in order to cater for the demand for leasing of construction machinery in Hong Kong.

業務回顧及市場前景

本集團在香港提供建築機械貿易及租賃服務。 我們的業務包括:(i)建築機械貿易,主要為地 基機械及鑽孔配件:(ii)建築機械租賃,主要為 電力及能源機械:及(iii)以吊臂式貨車提供本 地運輸服務。

由於全球經濟復甦緩慢,建築項目需求大為收 縮,這亦導致建築機械製造業收縮及產量過 剩。作為全球國際大都市之一,香港無疑已受 到宏觀經濟環境的影響。此外,香港的建築業 受政治阻撓影響,導致不少建築項目延期。

儘管如此,十大基建項目大力推動了香港建築 市場發展。預期多個新項目如公共及私人房屋 計劃以及機場興建新跑道,將於未來數年在香 港政府支持下作為基建計劃其中部分而付諸實 行。隨著長遠建築項目需求增加,承建商可能 會維持機隊以確保高效運作。因此,我們相 信,建築項目的開展及於市場上保持我們的競 爭優勢將導致客戶的需求不斷增加,進而為我 們的收益帶來貢獻。

此外,於二零一七年三月三十一日,我們擁有 一支逾600台電力及能源機械的租賃機隊,包 括多款不同型號及標準的發電機及空氣壓縮 機。為迎合香港建築機械的租賃需求,我們按 計劃繼續擴充我們的租賃機隊並保持我們在主 要類別機械(即電力及能源機械)方面的優勢。

To improve cost-efficiency and the monitoring of delivery of leasing machinery to our customers, we have developed transportation services by leasing of crane lorries with various lifting capacity to customers to not only unload, hoist and install heavy components of construction machinery, but also perform the function of transportation of these components and raw materials among construction sites. We have expanded our transportation services during the Year with improved performance. We believe that the development of transportation services would be welcomed by our customers and help to maintain our quality of services in leasing operation as well.

FINANCIAL REVIEW

Revenue

Our total revenue decreased by approximately HK\$29.5 million, or 14.4%, from approximately HK\$205.4 million for the Previous Year to approximately HK\$175.9 million for the Year. Such decrease was mainly attributable to the combined effect from (i) the drop in revenue from trading of construction machinery and (ii) the increase in revenue from leasing of construction machinery and transportation services.

Trading of construction machinery

Our Group's revenue generated from trading of construction machinery recorded a decrease by approximately HK\$44.9 million, or approximately 32.7%, from approximately HK\$137.1 million for the Previous Year to approximately HK\$92.2 million for the Year. Such decrease was mainly attributable to the decrease in trading volume of construction machinery due to the delay in commencement of several public projects and public-related projects which reduced the demand of construction machinery in the industry.

Leasing of construction machinery

Our Group's revenue generated from leasing of construction machinery recorded an increase by approximately HK\$7.2 million, or approximately 10.7%, from approximately HK\$67.0 million for the Previous Year to approximately HK\$74.2 million for the Year. Such increase was mainly due to the increase in leasing of power generators for the Year.

為改善成本效益及監督向我們的客戶付運租賃 機械的情況,我們透過向客戶出租具有不同起 重能力的吊臂式貨車提供運輸服務,不僅可卸 載、起吊及安裝建築機械較重的部件,而且還 可在建築工地上運輸該等部件及原材料。我們 已於本年度擴充我們的運輸服務,表現亦有所 改善。我們認為,發展運輸服務將會受客戶歡 迎,亦有助維持我們租賃業務的服務質素。

財務回顧

收益

我們的收益總額由上一年度約205.4百萬港 元減少約29.5百萬港元或14.4%至本年度約 175.9百萬港元。有關減少主要是由於(i)來自 建築機械貿易的收益下降及(ii)來自建築機械租 賃及運輸服務的收益增加的綜合影響所致。

建築機械貿易

本集團建築機械貿易所產生收益由上一年度約137.1百萬港元減少約44.9百萬港元或約 32.7%至本年度約92.2百萬港元。有關減少主 要是由於若干公共項目及相關公共項目延遲動 工,導致業內對建築機械的需求減少,建築機 械的成交量因而下跌所致。

建築機械租賃

本集團建築機械租賃所產生收益由上一年度約 67.0百萬港元增加約7.2百萬港元或約10.7% 至本年度約74.2百萬港元。有關增加主要是由 於本年度發電機租賃增加所致。

Transportation services

Our Group's revenue generated from transportation services increased by approximately HK\$8.2 million, or 630.8%, from approximately HK\$1.3 million for the Previous Year to approximately HK\$9.5 million for the Year, as the transportation business has been commenced since July 2015 and was in a full year operation for the Year.

Cost of Sales and Services

Our Group's cost of sales and services amounted to approximately HK\$115.0 million for the Year, representing a decrease of approximately 22.0% (2016: approximately HK\$147.5 million). Cost of sales and services mainly comprised of costs of machinery and equipment and spare parts, staff costs and depreciation, which together accounted for approximately 89.2% (2016: 91.7%) of the Group's total cost of sales and services for the Year.

Among the three major items under cost of sales and services, the Group recorded a decrease of approximately 35.7% in costs of machinery and equipment and spare parts, which is in line with the decrease in trading business for the Year. Staff costs increased substantially by approximately 64.3% due to an increase in staff headcount to cope with business expansion and annual salary increment for the Year. Depreciation increased by approximately 19.7% mainly due to additions of machinery and equipment and crane lorries as a result of the expansion of the Group's owned fleet and transportation service respectively.

Gross Profit and Gross Profit Margin

Our Group's gross profit increased by approximately HK\$2.8 million, or 4.8%, from approximately HK\$58.0 million for the Previous Year to approximately HK\$60.8 million for the Year, while our gross profit margin increased from approximately 28.2% for the Previous Year to approximately 34.6% for the Year. The increased in gross profit and gross profit margin was due to higher gross profit contributed by our trading and leasing business.

Besides, since the transportation business was commenced in July 2015 and hence the related gross loss decreased by a significant margin as this business segment continues to develop for the Year.

運輸服務

由於本集團自二零一五年七月以來開始並於本 年度全年經營運輸業務,故本集團運輸服務所 產生收益由上一年度約1.3百萬港元增加約8.2 百萬港元或630.8%至本年度約9.5百萬港元。

銷售及服務成本

本集團於本年度的銷售及服務成本約為115.0 百萬港元,減少約22.0%(二零一六年:約 147.5百萬港元)。銷售及服務成本主要包括 機械、設備及備用零件成本、員工成本以及折 舊,合共佔本集團於本年度銷售及服務成本總 額的約89.2%(二零一六年:91.7%)。

於銷售及服務成本項下的三個主要項目中, 本集團的機械、設備及備用零件成本減少約 35.7%,與本年度貿易業務下滑的情況一致。 由於本年度為應對業務擴充而增加員工人數及 年度薪金遞增,員工成本大幅增加約64.3%。 折舊增加約19.7%,主要是由於本集團分別擴 充自有機隊及運輸服務,而添置機械及設備以 及吊臂式貨車所致。

毛利及毛利率

本集團的毛利由上一年度約58.0百萬港元增加約2.8百萬港元或4.8%至本年度約60.8百萬港元,而我們的毛利率由上一年度約28.2%增加至本年度約34.6%。毛利及毛利率增加乃由於我們的貿易及租賃業務貢獻較高毛利所致。

此外,運輸業務於二零一五年七月開始業務。 隨著該業務分部於本年度不斷發展利潤率大幅 增加,相應毛損亦因此減少。

Other Income and Gains

Our Group's other income and gains increased by approximately HK\$1.5 million, or 2,419.4%, from approximately HK\$62,000 loss for the Previous Year to approximately HK\$1.4 million gain for the Year. The increase in other income and gains was mainly attributable to the gain on disposal of property, plant and equipment of approximately HK\$1.3 million for the Year.

Selling Expenses

Our Group's selling expenses decreased by approximately HK\$0.6 million, or approximately 17.1%, from approximately HK\$3.5 million for the Previous Year to approximately HK\$2.9 million for the Year, mainly due to the decrease in staff costs in the selling department.

Administrative Expenses

Our Group's administrative expenses increased by approximately HK\$20.7 million, or 150.0%, from approximately HK\$13.8 million for the Previous Year to approximately HK\$34.5 million for the Year. The increase in administrative expenses was mainly attributable to (i) the recognition of the one-off listing expenses as anticipated and disclosed in the prospectus of the Company dated 27 January 2017 (the "**Prospectus**") and (ii) the increase in staff costs and expenses.

Finance Income

Our Group's finance income increased by approximately HK\$729,000 or 318.3%, from approximately HK\$229,000 for the Previous Year to approximately HK\$958,000 for the Year, was mainly attributable to the finance lease interest income generated from our customers and interest income generated from bank deposits.

Finance Costs

Our Group's finance costs increased by approximately HK\$0.9 million, or 100%, from approximately HK\$0.9 million for the Previous Year to approximately HK\$1.8 million for the Year. The increase in finance costs was mainly attributable to the increase in borrowings and obligations under finance leases for the Year.

其他收入及收益

本集團的其他收入及收益由上一年度虧損約 62,000港元增加約1.5百萬港元或2,419.4% 至本年度收益約1.4百萬港元。其他收入及收 益增加主要是由於本年度出售物業、廠房及設 備的收益約1.3百萬港元所致。

銷售開支

本集團的銷售開支由上一年度約3.5百萬港元 減少約0.6百萬港元或約17.1%至本年度約2.9 百萬港元,主要是由於銷售部門的員工成本減 少所致。

行政開支

本集團的行政開支由上一年度約13.8百萬港 元增加約20.7百萬港元或150.0%至本年度約 34.5百萬港元。行政開支增加主要是由於(i)確 認本公司日期為二零一七年一月二十七日的招 股章程(「招股章程」)中所預計及披露的一次性 上市開支;及(ii)員工成本及開支增加。

財務收入

本集團的財務收入由上一年度約229,000港 元增加約729,000港元或318.3%至本年度約 958,000港元,主要是來自我們客戶的融資租 賃利息收入及銀行存款的利息收入所致。

財務成本

本集團的財務成本由上一年度約0.9百萬港元 增加約0.9百萬港元或100%至本年度約1.8百 萬港元。財務成本增加主要是由於本年度借款 及融資租賃責任增加所致。

Income Tax Expenses and Effective Tax Rate

Our Group's income tax expenses decreased by approximately HK\$0.1 million, or approximately 1.4%, from approximately HK\$6.9 million for the Previous Year to approximately HK\$6.8 million for the Year. Such decrease was in line with our profit before income tax and non-deductible listing expenses.

Our Group's effective tax rate increased from approximately 17.4% for the Previous Year to approximately 28.2% for the Year, which was due to non-deductible listing expenses.

Net Profit and Net Profit Margin

Our Group's net profit decreased by approximately HK\$15.8 million, from approximately HK\$33.0 million for the Previous Year to HK\$17.2 million for the Year, representing a net profit decline of approximately 47.9%.

Our Group's net profit margin were approximately 9.8% for the Year and 16.1% for the Previous Year, where the decrease was mainly due to the reasons illustrated above.

LIQUIDITY AND FINANCIAL RESOURCES REVIEW

The Group financed its operations through a combination of cash flow from operations, borrowings and obligations under finance leases. As at 31 March 2017, the Group had cash and cash equivalents of approximately HK\$133.8 million (2016: approximately HK\$37.4 million) which were mainly denominated in HK\$, Japanese Yen ("**JPY**"), EURO Dollar ("**EUR**") and United States Dollar ("**USD**"), and had borrowings of approximately HK\$42.7 million (2016: approximately HK\$23.3 million) and obligations under finance leases of approximately HK\$19.8 million (2016: approximately HK\$15.1 million) respectively that were denominated in HK\$.

Gearing ratio is calculated by dividing total debts (including borrowings and obligations under finance leases) by total equity at the end of the reporting period. The decrease of gearing ratio from approximately 32.4% as at 31 March 2016 to 25.1% as at 31 March 2017 was mainly due to the combined effect of the increases in (i) obligations under finance leases; (ii) interest-bearing borrowings; and (iii) equity due to the receipts of listing proceeds and profit generated for the Year.

所得税開支及實際税率

本集團的所得税開支由上一年度約6.9百萬港 元減少約0.1百萬港元或約1.4%至本年度約6.8 百萬港元。有關減少與除所得税前溢利及不可 扣税上市開支一致。

本集團的實際税率由上一年度約17.4%升至本 年度約28.2%,此乃由於不可扣税上市開支所 致。

純利及純利率

本集團的純利由上一年度約33.0百萬港元減 少約15.8百萬港元至本年度的17.2百萬港元, 相當於純利減少約47.9%。

本集團本年度及上一年度的純利率分別約為 9.8%及16.1%,純利率下跌主要是由於上述 原因所致。

流動資金及財務資源回顧

本集團透過來自經營活動的現金流量、借款及 融資租賃責任相結合的方式為其營運撥付資 金。於二零一七年三月三十一日,本集團有現 金及現金等價物約133.8百萬港元(二零一六 年:約37.4百萬港元)主要以港元、日圓(「日 圓」)、歐元(「歐元」)及美元(「美元」)計值, 以及有借款約42.7百萬港元(二零一六年:約 23.3百萬港元)及融資租賃責任約19.8百萬港 元(二零一六年:約15.1百萬港元)分別以港 元計值。

截至報告期末日的資產負債比率基於總債務 (包括借款及融資租賃責任)除以權益總額計 算。資產負債比率由二零一六年三月三十一日 的約32.4%減少至二零一七年三月三十一日的 25.1%,乃主要由於(I)融資租賃責任;(II)計息 借款;及(III)因收取上市所得款項及本年度產 生溢利而導致的權益增加的綜合影響所致。

As at 31 March 2017, our Group's total current assets and current liabilities were approximately HK\$207.8 million (2016: approximately HK\$93.3 million) and approximately HK\$92.8 million (2016: approximately HK\$84.2 million) respectively. Our Group's current ratio increased to approximately 2.2 times as at 31 March 2017 (2016: 1.1 times). The current ratio increased mainly due to the fact that the current assets growth in terms of amount and percentage. The increase in our current assets as at 31 March 2017 was mainly caused by the increase in cash and cash equivalents as a result of the Listing and trade and bills receivables.

Going forward, the Group expects to fund its future operations and expansion plans primarily with cash generated from operations, borrowings and the net proceeds received by the Company through the Listing.

PLEDGE OF ASSETS

As at 31 March 2017, our borrowings and obligations under finance leases were secured by property, plant and equipment with net carrying amount of approximately HK\$74.9 million (2016: approximately HK\$20.0 million).

CAPITAL EXPENDITURE

The total capital expenditure incurred for the Year was approximately HK\$92.8 million (2016: approximately HK\$32.6 million) which was mainly used in purchase of machinery for our leasing business.

CURRENCY RISK

Certain transactions of the Group are denominated in currencies which are different from the functional currency of the Group, namely, HK\$, and therefore the Group is exposed to foreign exchange risk. Payments made by the Group for the settlement of its purchases from suppliers are generally denominated in HK\$, JPY, USD and EUR. Payments received by the Group from its customers are mainly denominated in HK\$.

The Group does not have a foreign currency hedging policy. However, the Group will continue to monitor closely its exposure to currency movement and take proactive measures. 於二零一七年三月三十一日,本集團的流動資 產及流動負債總額分別約為207.8百萬港元(二 零一六年:約93.3百萬港元)及約92.8百萬港 元(二零一六年:約84.2百萬港元)。本集團 的流動比率於二零一七年三月三十一日增加至 約2.2倍(二零一六年:1.1倍)。流動比率增 加主要由於流動資產的金額及百分比增加所 致。本集團於二零一七年三月三十一日的流動 資產增加,主要由於現金及現金等價物因上市 而有所增加以及貿易應收款項及應收票據增加 所致。

展望未來,本集團預期主要以經營所得現金、 借款及本公司透過上市收取的所得款項淨額為 其未來營運及擴展計劃撥付資金。

資產抵押

於二零一七年三月三十一日,我們的借款及融 資租賃責任以賬面值淨額為約74.9百萬港元 (二零一六年:約20.0百萬港元)的物業、廠 房及設備作抵押。

資本開支

於本年度產生的資本開支總額約為92.8百萬港 元(二零一六年:約32.6百萬港元),主要用 於為我們的租賃業務購買機器。

貨幣風險

本集團若干交易以有別於本集團功能貨幣(即 港元)的貨幣計值,因此,本集團面臨外匯風 險。本集團為結算其向供應商的採購款而支付 的款項一般以港元、日圓、美元及歐元計值。 本集團自其客戶收取的付款主要以港元計值。

本集團並無外幣對沖政策。然而,本集團將繼 續密切監察其面臨的貨幣變動風險及採取積極 措施。

CONTINGENT LIABILITIES

The Group had no material contingent liabilities at the end of the reporting period (2016: nil).

CAPITAL COMMITMENTS

Our capital commitments consist primarily of purchase of construction machinery for leasing purpose. As at 31 March 2017, there were no (2016: approximately HK\$30.8 million) capital commitments of property, plant and equipment contracted but not provided for.

EMPLOYEES AND REMUNERATION POLICY

As at 31 March 2017, our Group had 40 staff (2016: 30). The total staff costs incurred by our Group for the Year were approximately HK\$17.9 million (2016: approximately HK\$10.3 million). The increase in staff costs was mainly due to increase in headcount and salary increment for the Year.

Employees' remuneration packages are determined with reference to the market information and individual performance and will be reviewed on a regular basis. The remuneration policy will be reviewed by the Board from time to time. In addition to basic remuneration, the Group also makes contributions to mandatory provident funds scheme and provides other benefits to the employees as mentioned in the Company's share option scheme as set out in the section headed "Report of the Directors". New employees are required to be equipped with the necessary skills and knowledge during induction programmes to perform their duties. In order to promote overall efficiency, we also offer technical trainings to our existing employees on the operation of more advanced construction machinery. Selected operation staff are chosen to attend external trainings which are conducted by the manufacturers to acquire up-to-date technical skills and knowledge on the products we rent and sell out to our customers.

Save for the business plan as disclosed in the Prospectus, there was no other plan for material investments or capital assets as at 31 March 2017.

USE OF NET PROCEEDS FROM THE LISTING

The receipt of proceeds net of listing expenses upon the Listing were approximately HK\$109.4 million. Since the net proceeds from the Listing were just received by the Company shortly before the end of the reporting period, the plan for the use of proceeds as disclosed in the Prospectus had not been executed yet as at 31 March 2017.

The unutilised net proceeds had been deposited into licensed banks in Hong Kong.

Neither the Company, nor any of its subsidiaries had sold, purchased or redeemed any of the Company's listed securities since the Listing Date.

Mr. Siu has more than 25 years of experience in the construction machinery industry.

Mr. Siu obtained a Bachelor of Engineering in Mechanical Engineering from the National Cheng Kung University, Taiwan in June 1973.

Ms. Wong Fei Heung Terbe (王菲香) ("**Mrs. Siu**"), aged 43, is our Company's executive Director, and is responsible for overseeing our Group's business development, in particular, liaising with our local customers. Mrs. Siu joined our Group in November 1998, and was appointed as our Company's executive Director on 16 August 2016. Mrs. Siu has more than 19 years of experience in the construction machinery industry.

Mrs. Siu was admitted to Secondary One of the Hong Kong Taoist Association Ching Chung Secondary School in September 1985, and left in July 1990 after completion of Secondary Five.

Ms. Yip Kam Ling (葉錦玲) ("**Ms. Yip**"), aged 47, is our Company's executive Director, and is responsible for attending to our Group's business development, administration and human resources matters. Since the Listing Date and up to the end of the reporting period, the Company has been in compliance with the requirements under rules 3.10(1) and 3.10(2) of the Listing Rules relating to the appointment of at least three independent non-executive Directors with at least one independent non-executive Director possessing appropriate professional qualifications or accounting or related financial management expertise. The Company has also complied with rule 3.10A of the Listing Rules relating to the appointment of independent non-executive Directors presenting at least one-third of the Board.

The Company believes that the diversity of the Board members will be immensely beneficial for the enhancement of the Company's performance. Therefore, the Company has adopted a Board diversity policy to ensure that the Company will, when determining the composition of the Board, consider the Board diversity in terms of, among other things, age, cultural and educational background, professional experience, skills and knowledge. The Board diversity policy sets out the approach towards achieving diversity on the Board. Pursuant to the Board diversity policy, all Board appointments will be based on merits, and candidates will be considered against objective criteria, having due regard for the benefits of diversity of the Board.

As each of the independent non-executive Directors has confirmed his independence pursuant to rule 3.13 of the Listing Rules, the Company considers all of them to be independent parties.

All Directors, including independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. Independent non-executive Directors are invited to serve on the Audit Committee, the Remuneration Committee and the Nomination Committee.

As regards the CG Code provision requiring directors to disclose the number and nature of offices held in public companies or organizations and other significant commitments as well as the identity and the time involved to the issuer, the Directors have agreed to disclose their commitments and any subsequent change to the Company in a timely manner.

DIRECTORS' CONTINUING PROFESSIONAL DEVELOPMENT

Each Director was provided with the necessary training and information to ensure that he/she has proper understanding of the responsibilities under the Listing Rules and the applicable law, rules and regulations. The Directors are encouraged to participate in continuous professional development courses and seminars to develop and refresh their knowledge and skills. The Company will continue to arrange suitable training and regular seminars to provide the Directors with updates on the latest developments and changes in the Listing Rules and other relevant legal and regulatory requirements from time to time. 本公司相信董事會成員多元化將對本公司加強 相對表現有利。因此本公司已採納董事會成員 多元化政策,以確保本公司在釐定董事會架構 組成時會從多方面考慮董事會多元化,包括年 齡、文化及教育背景、專業經驗、技能及知 識。董事會多元化政策載有實現董事會多元化 的方法。根據董事會多元化政策,董事會所有 委任均以用人唯才為原則,衡量候選人時會考 慮客觀條件及董事會多元化的益處。

CHAIRMAN AND CHIEF EXECUTIVE

Under code provision A.2.1 of the CG Code, the roles of chairman and chief executive should be separate and should not be performed by the same individual. The division of responsibilities between the chairman and the chief executive should be clearly established and set out in writing. Since the Listing Date and up to the end of the reporting period, the Company had complied with code provision A.2.1 of the CG Code.

Mr. Siu Chun Yiu Jonathan is the Chairman of the Board and is responsible for major decision-making, implementation of business strategies and overseeing the overall operation of the Group. The Company has no such position as the chief executive and therefore the daily operation and management of the Group is monitored by the executive Directors as well as the senior management.

The Board is of the view that, notwithstanding without the presence of a chief executive, the balance of power and authority is ensured by the operation of the Board, which comprises experienced individuals who would meet from time to time to discuss issues affecting the operation of the Group.

APPOINTMENT AND RE-ELECTION OF DIRECTORS

Each of the executive Directors has signed a service contract with the Company for a term of three years commencing from their respective date of appointment subject to termination as provided in the service contract.

Each of the independent non-executive Directors has signed an appointment letter with the Company for a term of two years commencing from their respective date of appointment.

The appointments of executive Directors and independent non-executive Directors are subject to the provisions of retirement and rotation of Directors under the articles of association of the Company (the "**Articles**") and the applicable Listing Rules. The procedures and process of appointment, re-election and removal of Directors are set out in the Articles.

In accordance with the article 16.18 of the Articles, at every annual general meeting, one-third of the Directors for the time being (or, if their number is not three or a multiple of three, then the number nearest to, but not less than, one-third) shall retire from office by rotation provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years. Any Director appointed pursuant to article 16.2 or article 16.3 of the Articles shall not be taken into account in determining which Directors are to retire by rotation. A retiring Director shall be eligible for re-election thereat. The Company at any annual general meeting at which any Directors retire may fill the vacated office by electing a like number of persons to be Directors.

根據細則第16.18條,於每年的股東週年大會 上,三分之一在任董事(或倘董事數目並非三 或三的倍數,則以最接近但不少於三分之一的 董事)須輪席告退,惟每名董事(包括按特定任 期獲委任的董事)均須最少每三年輪席告退一 次。根據細則第16.2條或第16.3條獲委任的 任何董事在釐定輪席告退的董事時不應計算在 內。任滿告退的董事的任期直至大會(其於該 大會退任並合資格再競選連任)結束時屆滿。 本公司於有任何董事任滿告退的任何股東週年 大會上,可再重選類似數目的人士出任董事以 填補空缺。

BOARD MEETINGS, GENERAL MEETINGS AND ATTENDANCE OF DIRECTORS

The Company intends to hold Board meetings regularly, at least four times a year, and at approximately quarterly intervals. Notices of not less than fourteen days will be given for all regular Board meetings to provide all Directors with an opportunity to attend and include matters in the agenda for a regular meeting.

For other Board and Board committee meetings, reasonable notice is generally given. The agenda and accompanying board papers are dispatched to the Directors or Board committee members at least three days before the meetings to ensure that they have sufficient time to review the papers and are adequately prepared for the meetings. When the Directors or Board committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the Chairman prior to the meeting. Minutes of meetings are kept by the company secretary with copies circulated to all Directors/Committee members for information and records.

Minutes of the Board meetings and Board committee meetings are recorded in sufficient detail about the matters considered by the Board and the Board committees and the decisions reached, including any concerns raised by the Directors/committee members. Draft minutes of each Board meeting and Board committee meeting are/will be sent to the Directors/committee members for comments within a reasonable time after the date on which the meeting is held. Minutes of the Board meetings are open for inspection by Directors.

The Company was listed on 10 February 2017. Since the Listing Date and up to the end of the reporting period, no Board meeting, annual general meeting and extraordinary general meeting of the Company had been held.

董事會會議, 股東大會及出 席董事

COMPLIANCE WITH THE MODEL CODE FOR SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "**Model Code**") set out in Appendix 10 to the Listing Rules as its own code of conduct regarding securities transactions by the Directors. The Company has made enquiries to all Directors regarding any non-compliance with the Model Code.

All the Directors confirmed that they have fully complied with the required standard set out in the Model Code since the Listing Date and up to the end of the reporting period.

RESPONSIBILITIES OF THE BOARD AND MANAGEMENT

The Board is responsible for all major matters of the Company, including approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, financial information, appointment of Directors and other significant financial and operational matters. Directors could have recourse to seek independent professional advice in performing their duties at the Company's expense.

The daily management, administration and operation of the Group are delegated to the senior management. The delegated functions and responsibilities are periodically reviewed by the Board. Approval has to be obtained from the Board prior to any significant transactions entered into by the management.

BOARD COMMITTEE

Audit Committee

The Audit Committee was established on 23 January 2017, with specific written terms of references with rule 3.22 of the Listing Rules and paragraph C3 of the CG Code. The Audit Committee comprises three members, namely Mr. Leung Siu Hong (Chairman), Mr. Chui Kwong Fun and Mr. Li Ching Wing, all of them are independent non-executive Directors.

遵守證券交易的標準守則

The principal duties of the Audit Committee include but not limited to the following:

- to make recommendation to the Board on the appointment, reappointment and removal of the external auditor, and to approve the remuneration and terms of engagement of the external auditor, and any questions of resignation or dismissal of that auditor;
- to review the adequacy and effectiveness of the Group's policies and procedures regarding internal controls (including financial, operational and compliance controls), risk management system and any statement by the Directors to be included in the annual accounts prior to endorsement by the Board;
- 3. to review the financial statements and to have familiarity with the financial reporting principles and practices applied by the Group in preparing its financial statements;
- 4. to review external auditor's independence, objectivity, effectiveness of the audit process and the scope of the external audit, including the engagement letter. The Audit Committee should understand the factors considered by the external auditor in determining their audit scope. The external audit fees are to be negotiated by management, and presented to the Audit Committee for review and approval annually;

The Company has complied with rule 3.21 of the Listing Rules in that the Audit Committee must comprise a minimum of three members and must be chaired by an independent non-executive Director who possesses appropriate professional qualifications or accounting or related financial management expertise as required in rule 3.10(2) of the Listing Rules. The written terms of reference of the Audit Committee are available on the websites of the Company.

The Nomination Committee currently comprises three members, including one executive Director namely Mr. Siu Chun Yiu Jonathan (Chairman), and two independent non-executive Directors namely Mr. Chui Kwong Fun and Mr. Li Ching Wing.

The principal duties of the Nomination Committee include the following:

- to review the structure, size and composition (including the skills, knowledge and experience) of the Board at least annually and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy;
- 2. to identify individuals suitably qualified to become members of the Board, and select or make recommendations to the Board on the selection of individuals nominated for directorship. In identifying suitable candidates, the Nomination Committee shall consider candidates on merit and against the objective criteria, with due regard for the benefits of diversity on the Board;
- to make recommendations to the Board on the appointment or reappointment of Directors, and succession planning for Directors, in particular, the chairman and the chief executive;
- to identify and nominate candidates to fill casual vacancies of Directors for the Board's approval;
- to assess the independence of independent non-executive Directors, and review the independent non-executive Directors' annual confirmations on their independence; and make disclosure of its review results in the corporate governance report;

Remuneration Committee

The Remuneration Committee was established on 23 January 2017, with specific written terms of references with rule 3.26 of the Listing Rules and paragraph B1 of the CG Code. The Remuneration Committee comprises three members, including two independent non-executive Directors namely Mr. Chui Kwong Fun (Chairman) and Mr. Li Ching Wing, one executive Director namely Ms. Yip Kam Ling.

The principal duties of the Remuneration Committee include but not limited to the following:

- to formulate remuneration policy for approval by the Board, which shall take into consideration factors such as salaries paid by comparable companies, time commitment and responsibility, employment conditions elsewhere in the Group, and individual performance of the Directors, senior management, and the general staff. Performance shall be measured against corporate goals and objectives resolved by the Board from time to time; and implement the remuneration policy laid down by the Board;
- to recommend to the Board the policy and structure for the remuneration of Directors, chief executive and senior management members, whilst ensuring no Director or any of his associates, or any senior management members is involved in deciding his own remuneration;

The Board adopts a board diversity policy. The Company recognises and embraces the benefits of having a diverse Board to enhance the quality of its performance. Diversity of Board members can be achieved through consideration of a number of factors, including but not limited to gender, age, cultural background and ethnicity, in addition to educational background, professional qualifications, industry and regional experience, skills, knowledge and length of service. All the Board appointments will be based on meritocracy, and candidates will be considered against appropriate criteria, having due regard for the benefits of diversity on the Board.

DIRECTORS' AND AUDITORS RESPONSIBILITY IN RESPECT OF THE FINANCIAL STATEMENTS

The Directors acknowledge their responsibility for the preparation of financial statements which give a true and fair view of the state of affairs of the Group. In preparing the financial statements which give a true and fair view, it is fundamental that the appropriate accounting policies are selected and applied consistently. The reporting responsibilities of the Company's external auditor on the consolidated financial statements of the Group are set out in the independent auditor's report on pages 53 to 59 of this annual report. The Directors were not aware of any material uncertainties relating to events or conditions which may cast significant doubt upon the Group's ability to continue as a going concern.

AUDITOR'S REMUNERATION

The remuneration for the audit services and non-audit services provided by the Auditor to the Group during the Year amounted to HK\$4 million and HK\$1.4 million respectively. The audit services consist of annual audit service of HK\$1.3 million and audit service provided in connection with initial public offering of the Company of HK\$2.7 million. 核數師酬金

於本年度,核數師就向本集團提供審計服務及 非審計服務的酬金分別為4百萬港元及1.4百 萬港元。審計服務包括年度審計股務1.3百萬 港元及有關本公司首次公開發售提供的審計服 務2.7百萬港元。非審計服務包括税項、內部 控制建議及其他服務。

RISK MANAGEMENT AND INTERNAL CONTROL

Responsibilities of the Board

The Board acknowledges its responsibility for overseeing the Group's risk management and internal control systems and reviewing the effectiveness of such systems through the Audit Committee on annual basis. The Audit Committee assists the Board in fulfilling its oversight and corporate roles in the Group's financial, operational, compliance, risk management, internal controls, while senior management designs, implements and monitors the risk management and internal control systems, and provide reports to the Board and the Audit Committee on the effectiveness of these systems. However, systems and internal controls can only provide reasonable and not absolute assurance against material misstatement or loss, as they are designed to manage, rather than eliminate the risk of failure to achieve the Group's business objectives.

Risk Management and Assessment

The Company has established formal risk assessment criteria for the Group. Senior management identify risks that potentially impact the key processes of their operations on an annual basis. Risks are scored and ranked by their impact on the business and the likelihood of their occurrence. Senior management assess the effectiveness of the existing controls and formulate risk mitigating activities. Results of the annual risk assessment are reported to the Audit Committee, including amongst other things, significant risks of the Group and the appropriate control activities to mitigate and/or transfer the identified risks.

Internal Control

The Company has established defined levels of responsibilities and reporting procedures. Controls have been designed and established to ensure that assets are safeguarded against improper use or disposal, financial and accounting records are maintained in accordance with relevant accounting standards and regulatory reporting requirements, and key risks that may impact on the Group's performance are identified and assessed.

The Company has internal audit function which is primarily responsible for developing various internal control manuals and procedures, conducting reviews on the key operational processes and the related internal controls to ensure compliance with the Group's risk management and internal control policies and procedures.

風險管理及內部控制 董事會的責任

風險管理及評估

本公司已為本集團制訂正式的風險評估準則。 高級管理層每年識別可能影響其主要運作程序 的相關風險。風險將按其對業務的影響程度及 其發生的可能性予以評分及排序。高級管理層 評估現有控制的成效及規劃減低風險的活動。 年度風險評估結果將向審核委員會匯報,包括 (其中包括)本集團的重大風險以及減低及/或 轉移所識別風險的適當控制活動。

內部控制

本公司已設定明確的職責級別及匯報程序。設 計及實施控制以確保保障資產不會被不當使用 或處置、根據相關會計標準及監管報告要求存 置財務及會計記錄以及識別及評估可能影響本 集團表現的主要風險。

本公司具有內部審計職能,主要負責制定各種 內部控制手冊及程序,檢討主要運作程序及相 關內部控制,以確保遵守本集團的風險管理及 內部控制政策及程序。

During the Year, the Company has engaged an external consultant to conduct a review over the Group's internal controls over financial reporting. Senior management has taken certain immediate remedial actions accordingly and had refined certain internal control procedures in due course. Issues identified were followed up for proper implementation.

Review of Risk Management and Internal Control Systems

The Audit Committee assists the Board in the review of the effectiveness of the Group's risk management and internal control systems on an ongoing basis. The Directors through the Audit Committees are kept informed of significant risks that may impact on the Group's performance. For the Year, the Board considered the risk management and internal control systems of the Group to be effective and adequate. The Audit Committee has reviewed and is satisfied with the adequacy of resources, staff qualifications and experience, training programmes and budget of the Group's accounting, and financial reporting function.

Procedures and controls over handling and dissemination of inside information

The Company is aware of its obligation under relevant sections of the Securities and Futures Ordinance (the "**SFO**") and the Listing Rules. An Inside Information Policy has been established to lay down practical guidelines on definition of inside information, compliance and reporting, disclosure and announcement of inside information. All members of the Board, senior management, head of departments, and staff who are likely to possess inside information are strictly bound by this policy. Staff who have access to inside information is required to keep the unpublished inside information confidential until relevant announcement is made. Failure to comply with such requirements may result in disciplinary actions.

COMPANY SECRETARY

The role of the company secretary of the Company is performed by Ms. Cheng Shing Yan. The company secretary is responsible for facilitating the Board's communications among Board members, the Shareholders and the management of the Company and ensuring the Board policies and procedures, as well as the applicable laws, rules and regulations are followed.

Ms. Cheng Shing Yan has confirmed that she took not less than 15 hours of relevant professional training during the Year in compliance with rule 3.29 of the Listing Rules.

The Company also recognises the importance of timely and non-selective disclosure of information, which will enable the Shareholders and investors to make the informed investment decisions.

To promote effective communication, the Company adopts a shareholders communication policy which aims at establishing a two-way relationship and communication between the Company and the Shareholders and maintains a website of the Company at www.sanrochk.com, where up-to-date information on the Company's business operations and developments, financial information, corporate governance practices and other information are available for public access.

SHAREHOLDERS' RIGHTS

We seriously take care the Shareholders' interest to ensure that they are treated fairly and are able to exercise their Shareholders' rights effectively. Shareholders are entitled by the Articles of the Company and are also encouraged to participate in the Company's general meetings.

Convening of extraordinary general meeting

In accordance with the Articles, any one or more Shareholders holding, at the date of deposit of the requisition, not less than one-tenth of the paid up capital of the Company having the right of voting at general meetings shall have the right, by written notice, to require an extraordinary general meeting (the "**EGM**") to be called by the Directors for the transaction of any business specified in such requisition. Such requisition shall be made in writing to the Board or the company secretary of the Company which is situated at Rooms 6-7, 18/F., Laws Commercial Plaza, 788 Cheung Sha Wan Road, Kowloon. The EGM shall be held within two months after the deposit of such requisition. If the Directors fail to proceed to convene such meeting within 21 days of such deposit, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Directors shall be reimbursed to the requisitionist(s) by the Company.

The Company was incorporated in the Cayman Islands on 25 July 2016 as an exempted company with limited liability under the Companies Law (Cap. 22, Law 3 of 1961, as consolidated and revised) of the Cayman Islands. In preparation of the Listing, the companies comprising the Group underwent the Reorganisation pursuant to which the Company became the holding company of the Group on 10 November 2016. For details of the Reorganisation, please refer to the paragraph headed "History, Development and Reorganisation" in the Prospectus.

The Company's shares have been listed on the Stock Exchange since 10 February 2017.

RESULTS AND APPROPRIATIONS

The results of the Group for the Year are set out in the consolidated statement of comprehensive income on page 60.

Before the shares of the Company were listed on the Stock Exchange, a final dividend in relation to the year ended 31 March 2016 of HK\$12.0 million and a special dividend of HK\$3.0 million, had been approved on 15 August 2016 and fully paid on 23 August 2016. The Board does not recommend the payment of a final dividend for the Year.

CHARITABLE DONATIONS

Charitable donations made by the Group during the Year amounted to HK\$1.0 million (2016: nil).

RELATIONSHIP WITH KEY STAKEHOLDERS

The Group's success depends on the support from key stakeholders which comprise employees, customers and suppliers.

Employees

The Group is committed to establish a close and caring relationship with its employees. The Company provides a fair and safe workplace, promotes diversity to our staff, provides competitive remuneration and benefits and career development opportunities based on their merits and performance. The Group also puts ongoing efforts to provide adequate trainings and development resources to the employees so that they can keep abreast of the latest development of the market and the industry and, at the same time, improve their performance and self-fulfillment in their positions.

Customers and suppliers

Our major customers include some of the major main contractors in Hong Kong, and meanwhile we directly source machinery from some overseas manufacturers. Many of our five largest customers and suppliers have established long term business relationship with us. We believe that such long term relationships represent confidence and trust from our business partners and acknowledgement of our ability.

與主要持份者的關係

僱員

本集團致力於與其僱員建立密切及關懷的關 係。本公司為員工提供公平及安全的工作環 境,促進員工多元化發展,並基於彼等的功績 及表現提供具競爭力的薪酬及福利以及職業發 展機會。本集團亦持續為僱員提供充分的培訓 及發展資源,讓彼等了解最新市場及行業發展 資訊,同時提高彼等的表現及在崗位中實現自 我發展。

客戶及供應商

我們的主要客戶包括香港部分主要的總承建 商,與此同時,我們向部分海外製造商直接 採購機械。我們與大多數五大客戶及供應商已 建立長期的業務關係。我們相信這種長期關係 代表業務夥伴的信心與信任及對我們能力的認 同。

The Group is able to build up close working relationship with our business partners and bring together our customers and suppliers to develop foundation technology. The Directors have frequent interactions with our customers regarding their feedbacks on the guality of our products which would then be reflected to our suppliers by us. Through this solid communication channel together with our experienced management team, the Directors believe that we are able to better understand our customers' needs as well as the market trend in order to make appropriate modifications or improvements to our products. In particular, we would reflect the market needs to our suppliers who would then make modifications based on our idea originations. Leveraging on our relationship, our major suppliers provide us technical and other support such as training on the function, operation and maintenance of their machinery. We believe our established relationship with suppliers also enable us to acquire various types of machinery to fulfil our customers needs in a timely manner and with favourable terms.

The Group also leases foundation machinery and air compressors from third party construction companies for which we would then sub-lease to our customers which, to the belief of the Directors, is of mutual benefit and would build up a closer business relationship between us and our customers.

ENVIRONMENTAL POLICIES AND PERFORMANCE

We believe that our business also depends on our ability to meet our customers' requirements in respect of safety, quality and environmental aspects. To meet our customers' requirements on safety, quality and environmental aspects, we have established and implemented various quality control measures in our operation process. Through the systematic and effective control of our operations, compliance with safety, quality and environmental requirements can be further assured.

1. Purpose of the Share Option Scheme

The purpose of the Share Option Scheme is to provide participants of the Share Option Scheme (the "**Participants**") with the opportunity to acquire proprietary interests in the Company and to encourage Participants to work towards enhancing the value of the Company and its Shares for the benefit of the Company and its Shareholders as a whole. The Share Option Scheme shall provide the Company with a flexible means of either retaining, incentivising, rewarding, remunerating, compensating and/or providing benefits to Participants.

2. Participants of the Share Option Scheme and the Basis of Determining the Eligibility of the Participants

On and subject to the terms of the Share Option Scheme and the requirements of the Listing Rules, the Board may offer to grant an option, to any Director(s) (including executive Directors, and independent non-executive Directors) and full-time employee(s) of any member of the Group and any advisers, consultants, contractors, subcontractors, suppliers, agents, customers, business partners, joint venture business partners, service providers of any member of the Group who the Board considers, in its absolute discretion and on such terms as it deems fit, grants options pursuant to the Share Option Scheme to.

3. Grant of options

On and subject to the terms of the Share Option Scheme and the requirements of the Listing Rules (in particular as to grant of options to Directors, chief executives and substantial shareholders of our Company or their respective associates), the Board shall be entitled at any time within 10 years after the date of adoption of the Share Option Scheme to make an offer for the grant of an option to any Participant as the Board may in its absolute discretion select. The offer shall specify the terms on which the option is granted. Such terms may include any minimum periods for which an option must be held and/or any minimum performance targets that must be reached, before the options can be exercised in whole or in part, and may include at the discretion of the Board other terms imposed (or not imposed) either on a case by case basis or generally.

5. Subscription price

The subscription price shall be such price as the Board may in its absolute discretion determine at the time of grant of the relevant option but the subscription price shall not be less than the highest of:

- the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date of grant;
- (b) the average closing price of the Shares as stated in the Stock Exchange's daily quotations sheets for the 5 business days immediately preceding the date of grant (provided that in the event that any option is proposed to be granted within a period of less than 5 business days after the trading of the Shares first commences on the Stock Exchange, the new issue price of the Shares for the offer of new Shares shall be used as the closing price for any business day falling within the period before listing of the Shares on the Stock Exchange); and
- (c) the nominal value of a Share on the date of grant.

6. Option period

The period within which the Shares must be taken up under an option shall be the period of time to be notified by the Board to each Grantee at the time of making an offer, which shall be determined by the Board in its absolute discretion at the time of grant, but such period must not exceed 10 years from the date of grant of the relevant option.

- (b) The Shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and other share option schemes of the Company (and to which the provisions of Chapter 17 of the Listing Rules are applicable) shall not exceed 120,000,000 Shares, representing 10% of the aggregate of the Shares in issue on the Listing Date (the "Scheme Mandate Limit");
- (c) The Company may refresh the Scheme Mandate Limit at any time subject to prior Shareholders' approval. However, the Scheme Mandate Limit as refreshed shall not exceed 10% of the Shares in issue as at the date of the aforesaid Shareholders' approval. 1 GENERAL INFORMATION, REORGANISATION AND BASIS OF PRESENTATION

1.1 General information

Sanroc International Holdings Limited (the "Company") is a limited liability company incorporated in the Cayman Islands. The address of its registered office is P.O. Box 309, Ugland House, Grand Cayman, KY1-1104, Cayman Islands.

The Company is an investment holding company and its subsidiaries (the "Group") are principally engaged in trading of machinery and spare parts, leasing of machinery and the provision of related services, and the provision of transportation services in Hong Kong.

Pursuant to the group reorganisation as set out in the section headed "History, Development and Reorganisation" in the Company's prospectus dated 27 January 2017 (the "Prospectus"), which was completed on 10 November 2016 (the "Reorganisation"), the Company became the holding company of its subsidiaries now comprising the Group. The shares of the Company were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 10 February 2017 (the "Listing Date") (collectively the "Listing").

The consolidated financial statements of the Group have been prepared as if the Group had always been in existence throughout both years presented, or since the respective dates of incorporation or establishment of the group companies, rather than from the date when the Company became the holding company pursuant to the Reorganisation.

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), unless otherwise stated.

2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

The consolidated financial statements of Sanroc International Holdings Limited have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs") and the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). The consolidated financial statements have been prepared under the historical cost convention.

The preparation of the financial statements in conformity with HKFRSs requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements, are disclosed in Note 4.

HKFRS 9 "Financial instruments" replaces the whole of HKAS 39. HKFRS 9 has three financial asset classification categories for investments in debt instruments: amortised cost, fair value through other comprehensive income ("OCI") and fair value through profit or loss. Classification is driven by the entity's business model for managing the debt instruments and their contractual cash flow characteristics. Investments in equity instruments are always measured at fair value. However, management can make an irrevocable election to present changes in fair value in OCI, provided the instrument is not held for trading. If the equity instrument is held for trading, changes in fair value are presented in profit or loss. For financial liabilities there are two classification categories: amortised cost and fair value through profit or loss. Where non-derivative financial liabilities are designated at fair value through profit or loss, the changes in the fair value due to changes in the liability's own credit risk are recognised in OCI, unless such changes in fair value would create an accounting mismatch in profit or loss, in which case, all fair value movements are recognised in profit or loss. There is no subsequent recycling of the amounts in OCI to profit or loss. For financial liabilities held for trading (including derivative financial liabilities), all changes in fair value are presented in profit or loss.

HKFRS 9 also introduces a new model for the recognition of impairment losses — the expected credit losses (ECL) model, which constitutes a change from the incurred loss model in HKAS 39. HKFRS 9 contains a 'three stage' approach, which is based on the change in credit quality of financial assets since initial recognition. Assets move through the three stages as credit quality changes and the stages dictate how an entity measures impairment losses and applies the effective interest rate method.

The new rules mean that on initial recognition of a non-credit impaired financial asset carried at amortised cost a day-1 loss equal to the 12-month ECL is recognised in profit or loss. In the case of accounts receivables this day-1 loss will be equal to their lifetime ECL. Where there is a significant increase in credit risk, impairment is measured using lifetime ECL rather than 12-month ECL.

During the year, all of the Group's financial assets and financial liabilities were carried at amortised costs without significant impairment on the former, the implementation of HKFRS 9 is not expected to result in any significant impact on the Group's financial position and results of operations.

HKFRS 16 Leases — The Group is a lessee of various machinery, offices and warehouses which are currently classified as operating leases. The Group's current accounting policy for such leases is set out in note 2.10. The Group's operating lease commitments as at 31 March 2017 and 2016 amounting to HK\$1,376,000 and HK\$806,000, respectively, which are not reflected in the consolidated balance sheets, are set out in note 24(b).

HKFRS 16 provides new provisions for the accounting treatment of leases and will in the future no longer allow lessees to account for certain leases outside the balance sheet. Instead, all long-term leases must be recognised in the balance sheet in the form of assets (for the rights of use) and lease liabilities (for the payment obligations). Short-term leases with a lease term of twelve months or less and leases of low-value assets are exempt from such reporting obligations. The new standard will therefore result in recognition of a right-to-use asset and an increase in lease liabilities in the balance sheet. In profit or loss, rental expenses will be replaced with depreciation and interest expense. The impacts on the Group's financial results and position upon the adoption of HKFRS16 as lessee of finance leases and operating leases are not expected to be material. The new standard is not expected to be applied by the Group until the financial year ended 31 March 2020.

HKFRS 15 "Revenue from Contracts with Customers" This new standard replaces the previous revenue standards: HKAS 18 "Revenue" and HKAS 11 "Construction Contracts", and the related Interpretations on revenue recognition. HKFRS 15 establishes a comprehensive framework for determining when to recognise revenue and how much revenue to recognise through a 5-step approach: (1) Identify the contract(s) with customer; (2) Identify separate performance obligations in a contract; (3) Determine the transaction price; (4) Allocate transaction price to performance obligations; and (5) Recognise revenue when performance obligation is satisfied. The core principle is that a company should recognise revenue to depict the transfer of promised goods or services to the customer in an amount that reflects the consideration to which the company expects to be entitled in exchange for those goods or services. It moves away from a revenue recognition model based on an "earnings processes" to an "asset-liability" approach based on transfer of control. HKFRS 15 provides specific guidance on capitalisation of contract cost, license arrangements and principal versus agent considerations. It also includes a cohesive set of disclosure requirements about the nature, amount, timing and uncertainty of revenue and cash flows arising from the entity's contracts with customers. The Group has three major revenue streams, namely (i) sales of machinery and spare parts and provision of related services and (ii) provision of transportation services, the performance obligations of which are substantially completed at the same point of time as the respective revenue is recognised in accordance with Note 2.21(a) and Note 2.21(c), and (iii) short-term leasing of machinery, the performance obligations of which are substantially completed over the lease period as the respective revenue is recognised in accordance with Note 2.21(b). Management has performed a preliminary assessment and expects that the implementation of the HKFRS 15 would not result in any significant impacts on the Group's financial position and results of operations. 2.2 Subsidiaries

2.2.1 Consolidation

A subsidiary is an entity (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

(a) Business combinations

The Group applies the acquisition method of accounting to account for business combinations. The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred to the former owners of the acquiree and the equity interests issued by the Group. The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date.

All other components of non-controlling interests are measured at their acquisition date fair value, unless another measurement basis is required by HKFRSs.

Acquisition-related costs are expensed as incurred.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is re-measured to fair value at the acquisition date; any gains or losses arising from such re-measurement are recognised in profit or loss.

Any contingent consideration to be transferred by the Group is recognised at fair value at the acquisition date. Subsequent changes to the fair value of the contingent consideration that is deemed to be an asset or liability is recognised in accordance with HKAS 39 either in profit or loss or as a charge to other comprehensive income. Contingent consideration that is classified as equity is not remeasured, and its subsequent settlement is accounted for within equity.

Intra-group transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of impairment of the transferred asset. When necessary, amounts reported by subsidiaries have been adjusted to confirm with the Group's accounting policies.

(b) Changes in ownership interests in subsidiaries without change of control

Transactions with non-controlling interests that do not result in loss of control are accounted for as equity transactions that is, as transactions with the owners of the subsidiary in their capacity as owners. The difference between fair value of any consideration paid and the relevant share acquired of the carrying value of net assets of the subsidiary is recorded in equity. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs.

Investments in subsidiaries are accounted for at cost less impairment. Cost includes direct attributable cost of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decisionmaker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors who make strategic decisions.

2.4 Foreign currency translation

(a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and the Group's presentation currency.

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are remeasured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss, except when deferred in other comprehensive income as qualifying cash flow hedges and qualifying net investment hedges.

Foreign exchange gains and losses that relate to borrowings and cash and cash equivalents are presented in profit or loss within 'finance income or costs'. All other foreign exchange gains and losses are presented in profit or loss within 'other income and gains/(losses), net'.

Translation differences on non-monetary financial assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss. Translation differences on non-monetary financial assets, such as equities classified as available-forsale, are included in other comprehensive income.

Property, plant and equipment are stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the assets' carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to profit or loss during the financial period in which they are incurred.

Depreciation of property, plant and equipment is calculated using the straight-line method to allocate their costs to their residual values over the estimated useful lives, as follows:

Gains or losses on disposals are determined by comparing proceeds with the carrying amount and are recognised within "other income and gains/(losses), net".

2.6 Impairment of non-financial assets

Assets that have an indefinite useful life or intangible assets not ready to use are not subject to amortisation and are tested annually for impairment. Assets that are subject to amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (cash generating units). Nonfinancial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

2.7 Financial assets

2.7.1 Classification

The Group classifies its financial assets in the following category: loans and receivables. The classification depends on the purpose for which the financial assets were acquired. Management determines the classification of its financial assets at initial recognition.

(a) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are included in current assets, except for the amounts that are settled or expected to be settled more than 12 months after the end of the reporting period. These are classified as non-current assets. The Group's loans and receivables comprise "finance lease receivables", "trade and bills receivables", "deposits and other receivables", "amounts due from related companies", "amount due from a director", "restricted cash" and "cash and cash equivalents" in the consolidated balance sheet. 2 主要會計政策概要(續)

Regular way purchases and sales of financial assets are recognised on the trade-date — the date on which the Group commits to purchase or sell the asset. Loans and receivables are initially recognised at fair value plus transaction costs. They are derecognised when the rights to receive cash flows have expired or have been transferred and the Group has transferred substantially all risks and rewards of ownership. Loans and receivables are subsequently carried at amortised cost using the effective interest method.

Finance lease receivables are recognised as loans and receivables for the purpose of derecognition and impairment.

2.8 Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the consolidated balance sheet when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the company or the counterparty.

2.9 Impairment of financial assets

The Group assesses at the end of each reporting period whether there is objective evidence that a financial asset or group of financial assets is impaired. A financial asset or a group of financial assets is impaired and impairment losses are incurred only if there is objective evidence of impairment as a result of one or more events that occurred after the initial recognition of the asset (a 'loss event') and that loss event (or events) has an impact on the estimated future cash flows of the financial asset or group of financial assets that can be reliably estimated.

2.8 抵銷金融工具

2.9 金融資產減值

2.9 Impairment of financial assets (Continued)

Evidence of impairment may include indications that the debtors or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation, and where observable data indicate that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

For loans and receivables, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate.

The carrying amount of the asset is reduced and the amount of the loss is recognised in profit or loss. If a loan has a variable interest rate, the discount rate for measuring any impairment loss is the current effective interest rate determined under the contract. As a practical expedient, the Group may measure impairment on the basis of an instrument's fair value using an observable market price.

If, in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised (such as an improvement in the debtor's credit rating), the reversal of the previously recognised impairment loss is recognised in profit or loss.

For finance lease receivables, the amount of loss impairment is measured as the difference between the carrying amount of the receivable and the present value of the estimated future cash flows, discounted at the implicit effective interest rate used on initial recognition.

2.10Lease

The Group as lessor

(a) Finance lease

A finance lease is a lease that the Group as the lessor uses to transfer substantially all the risks and rewards incidental to ownership of the leased asset to the lessee. At the commencement of the lease term, the Group recognises the minimum lease amounts receivable by the Group as a finance lease receivable. The difference between (a) the aggregate of the minimum lease amounts and (b) their present value (presented in the consolidated balance sheet as finance lease receivables) is recognised as unearned finance income. Minimum lease amounts are the payments over the lease term that the lessee is or can be required to make.

Unearned finance income is allocated to each period during the lease term using the effective interest method that allocates each rental between finance income and repayment of capital in each accounting period in such a way that finance income is recognised as a constant periodic rate of return (implicit effective interest rate) on the lessor's net investment in the lease.

Initial direct costs, such as commissions, legal fees and internal costs that are incremental and directly attributable to negotiating and arranging a lease, are included in the initial measurement of the finance lease receivable and reduce the amount of income recognised over the lease term.

See notes 2.7 and 2.9 for accounting policies for derecognition and impairment of finance lease receivables.

A lease is classified as an operating lease if it does not transfer substantially all the risks and rewards incidental to ownership of the leased asset to the lessee. Amounts received from lessees under operating leases (net of any incentives grant to the lessee) are recognised in profit or loss on a straight-line basis over the period of the lease.

The Group as lessee

(c) Finance lease

The Group leases certain machinery and equipment. Leases of machinery and equipment where the Group has substantially all the risks and rewards of ownership, are classified as finance leases. Finance leases are capitalised at the lease's commencement at the lower of the fair value of the leased machinery and equipment and the present value of the minimum lease payments.

Each lease payment is allocated between the liability and finance charges. The corresponding rental obligations, net of finance charges, are included in other short-term and other long-term payables. The interest element of the finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period. The machinery and equipment acquired under finance leases is depreciated over the shorter of the useful life of the asset and the lease term.

(d) Operating lease

Leases in which a significant portion of the risks and rewards of ownership are retained by the lessor are classified as operating leases. Payments made under operating leases (net of any incentives received from the lessor) are charged to profit or loss on a straight-line basis over the period of the lease.

2.11 Trade and bills receivables, deposits and other receivables, amount due from a director and amounts due from related companies

Trade receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business. If collection of trade and bills receivables, deposits and other receivables, amount due from a director and amounts due from related companies are expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade and bills receivables, deposits and other receivables, amount due from a director and amounts due from related companies are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment.

2.12Inventories

Inventories comprise machinery and equipment, construction work materials and consumables and are stated at the lower of cost and net realisable value. Cost is determined using first-in, first-out (FIFO) method. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

2.13Cash and cash equivalents and restricted cash

In the consolidated statement of cash flows, cash and cash equivalents include cash on hand and deposits held at call with banks with original maturity of three months or less.

Bank deposits which are restricted to use are included in "restricted cash". Restricted cash is excluded from cash and cash equivalents in the consolidated cash flow statements.

2.14Share capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares are shown in equity as a deduction, net of tax, from the proceeds.

2.15Trade and bills payables, other payables, amounts due to directors and amounts due to related companies

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade and bills payables, other payables, amounts due to directors and amounts due to related companies are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

Trade and bills payables, other payables, amounts due to directors and amounts due to related companies are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

2.16Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in profit or loss over the period of the borrowings using the effective interest method.

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw-down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a pre-payment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least twelve months after the balance sheet date.

2.17Borrowing costs

General and specific borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

2.18Provisions

Provisions are recognised when: the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

The tax expense for the period comprises current and deferred income tax. Tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

(a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

(b) Deferred income tax Inside basis differences

> Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill, the deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled. Deferred income tax assets are recognised only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

(c) Offsetting

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred income taxes assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

2.20Employee benefits

(a) Employee leave entitlements

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the balance sheet date.

Employee entitlements to sick leave and maternity or paternity leaves are not recognised until the time of leave.

Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

(c) Termination benefits

Termination benefits are payable when employment is terminated by the Group before the normal retirement date, or whenever an employee accepts voluntary redundancy in exchange for these benefits. The Group recognises termination benefits when it is demonstrably committed to a termination when the entity has a detailed formal plan to terminate the employment of current employees without possibility of withdrawal. In the case of an offer made to encourage voluntary redundancy, the termination benefits are measured based on the number of employees expected to accept the offer. Benefits falling due more than twelve months after balance sheet date are discounted to present value.

2.21 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable for the sale of goods and services rendered in the normal course of business, net of discounts and sales related taxes.

The Group recognises revenue when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of the Group's activities as described below. The Group bases its estimates on historical results, taking into consideration the type of customers, type of transactions and the specifics of each arrangement.

(a) Sales of goods

Sales of goods are recognised when products are delivered to customers and the customers accept the products. Collectability of the related receivables is reasonably assured.

(b) Rental income

Rental income from rental of machinery is recognised based on the straight-line basis over the lease terms.

(c) Service income

Service income of the provision of transportation, repairing and maintenance services for machinery and equipment is recognised when services are provided.

2.22Interest income

Interest income is recognised using the effective interest method. When a loan and receivable is impaired, the Group reduces the carrying amount to its recoverable amount, being the estimated future cash flow discounted at the original effective interest rate of the instrument, and continues unwinding the discount as interest income. Interest income on impaired loans and receivables is recognised using the original effective interest rate.

2.23 Dividend distribution

3 FINANCIAL RISK MANAGEMENT

3.1 Financial risk factors

The Group's activities expose it to a variety of financial risk: market risk (including foreign exchange risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of the financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Risk management is carried out under policies approved by the board of directors. The Directors provide principles for an overall risk management, as well as policies covering specific areas.

- (a) Market risk
 - (i) Foreign exchange risk

The Group operates mainly in Hong Kong, and is exposed to foreign currency risks arising from various currency exposures, mainly with respect to Japanese Yen ("JPY"), European dollar ("EUR") and US dollar ("USD"). Foreign exchange risk arises from future commercial transactions and recognised assets and liabilities which are denominated in a currency that is not the Company's functional currency. Since HK\$ is pegged with USD, management is of the opinion that the foreign exchange risk arising from USD is insignificant.

For settlement of the purchase to suppliers in JPY or EUR, once the purchase order is placed, provided that there is time difference (at least over one week) for the payments to suppliers, management may consider to enter into foreign exchange forward contract with its principal bank on a case-by-case basis. Several factors are considered by management before entering into any hedging contracts, such as (i) the extent of the exchange rate fluctuations in the market; (ii) the exposure period before settlement of the purchase; and (iii) the contract amount of the purchase agreement.

 - (i) 外匯風險

本集團主要於香港經營業 務,並面臨來自多種貨幣(主 要與日圓(「日圓」)、歐元 (「歐元」)及美元(「美元」)有 關)的外幣風險。外匯風險產 生自未來商業交易以及以並 非本公司功能貨幣的貨幣計 值的已確認資產和負債。由 於港元與美元掛鈎,管理層 認為因美元產生的外匯風險 微乎其微。

對於以日圓或歐元向供應商 結算採購款,當發出採購訂 單後,倘向供應商付款存 時差(至少一週),管理 不 處逐項與主要往來銀行 訂立任何對 之外匯遠期合約。管理 了立任何對沖合約前 考 處 了 前 馬 長 (ii)結算採購 該 的 國 險期;及 (iii)採購 協 義 的 金額。

 - (i) Interest rate risk

The Group has no significant interests-bearing assets except for cash at bank, details of which are disclosed in note 18. The Group is exposed to interest rate risk when borrowings are carried at floating rates. It is the Group's policy to maintain its borrowings subject to floating rates, and accordingly, the Group has not used any interest rate swaps to hedge its exposure to interest rate risk.

As at 31 March 2017, all the borrowings are carried at fixed interest rates. As at 31 March 2016, borrowings of HK\$3,313,000 and HK\$19,987,000 are carried at fixed and floating interest rates, respectively. For the year ended 31 March 2016, if the interest rates on borrowings had been 100 basis-points higher/lower with all other variables held constant, the profit before tax would be HK\$200,000 lower/higher, respectively, mainly as a result of higher/lower interest expense on floating rate borrowings.

(b) Credit risk

The Group is exposed to credit risk in relation to its cash and cash equivalents, finance lease receivables, trade and bills receivables, deposits and other receivables, amount due from a director and amounts due from related companies. The Group's maximum exposure to credit risk is the carrying amounts of these financial assets.

The Group has concentration of credit risk as 48% (2016: 55%) of the total trade receivables were due from the Group's top five (2016: five) customers, which constituted 55% of the Group's revenue for the year ended 31 March 2017 (2016: 59%).

To manage this risk, management has monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, management reviews regularly the recoverable amount of each individual trade receivable to ensure that adequate impairment provision is made for the irrecoverable amounts.

The credit risk on deposits with bank and amounts due from related companies are limited because deposits are in banks with sound credit ratings and management does not expect any loss from non-performance by related parties.

(c) Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash and cash equivalents and the availability of funding through an adequate amount of committed credit facilities.

The Group's primary cash requirements have been for additions of machinery and equipment, and payment for purchases and operating expenses. The Group mainly finances its working capital requirements through internal resources and bank borrowings.

The Group monitors and maintains a level of cash and cash equivalents considered adequate by the directors to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The directors monitor the utilisation of bank borrowings to ensure adequate unutilised banking facilities and compliance with loan covenants.

The table below analyses the Group's financial liabilities and net-settled derivative financial liabilities into relevant maturity groupings based on the remaining period at the balance sheet date to the contractual maturity date. The amounts disclosed in the table represent the contractual undiscounted cash flows.

3.2 Capital risk management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

The capital structure of the Group consists of equity, amounts due to directors and related companies and borrowings. In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends to shareholders, return capital to shareholders, issue new shares or sell assets to reduce borrowings.

The Group monitors capital on the basis of gearing ratio. The gearing ratio is calculated as net debt divided by total equity. Net debt is calculated as total borrowings (including amounts due to directors and related companies with non-trade in nature) less cash and cash equivalents and restricted cash. The gearing ratios were as follows:

The carrying amount of the Group's financial assets and liabilities, including cash and cash equivalents, restricted cash, finance lease receivables, trade and bills receivables, deposits and other receivables, amount due from a director and related companies, trade and bills payables, other payables, amounts due to directors and related companies, obligations under finance leases and borrowings approximate their fair values, which either due to their short-term maturities, or that they are subject to floating rates.

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

(a) Estimated useful lives and residual values of property, plant and equipment

Management estimates useful lives of the property, plant and equipment by reference to the Group's business model, its assets management policy, the industry practice, expected usage of the assets, expected repair and maintenance, the technical or commercial obsolescence arising from changes or improvements in the market. Residual values of the property, plant and equipment are determined based on prevailing market values for equivalent aged assets taking into account the condition of the relevant assets and other economic considerations. Depreciation expense would be significantly affected by the useful lives and residual values of the property, plant and equipment as estimated by management.

The Group's major operating assets represent property, plant and equipment. Management performs review for impairment of the property, plant and equipment whenever events or changes in circumstances indicate that the carrying amounts of these assets may not be recoverable.

Management considered there was no impairment indicator of property, plant and equipment during the year ended 31 March 2017 as these assets were used for profitable projects, and there is a strong demand of these property, plant and equipment in the second hand market (2016: same).

4 重要會計估計及判斷

估計及判斷乃依據過去經驗及其他因素 (包括在某些情況下對未來事件作出被認 為合理的預期)作持續評估。

本集團對未來作出估計及假設。按定 義,所得的會計估計甚少等同相關實際 結果。下文討論有重大風險會引致需對 下一個財政年度內的資產及負債賬面值 作出重大調整的估計及假設。

(a) 物業、廠房及設備的估計可使 用年期及剩餘價值

管理層乃參考本集團的業務模式、其資 產管理政策、行業慣例、資產預期用 途、預期維修及保養、因市場變化或改 善導致的技術或商業方面過時,估計物 業、廠房及設備的可使用年期。物業、 廠房及設備的剩餘價值乃根據具同等賬 齡資產的現行市值釐定,並計及有關資 產的狀況及其他經濟考慮因素。管理層 所估計物業、廠房及設備的可使用年期 及剩餘價值將對折舊開支有重大影響。

本集團的主要營運資產為物業、廠房及 設備。倘有事件發生或情況改變顯示物 業、廠房及設備的賬面值可能無法收回 時,管理層會對該等資產進行減值評估。

管理層認為,物業、廠房及設備於截至 二零一七年三月三十一日止年度並無減 值跡象(二零一六年:無),原因是該等 資產用於可賺取利潤的項目且二手市場 對該等物業、廠房及設備的需求強勁。

(b) Impairment of trade and bills receivables

Management determines the provision for impairment of trade and bills receivables based on the credit history of customers and the current market condition by business segment. Significant judgment is exercised on the assessment of the collectability of receivables from each customer. In making the judgment, management considers a wide range of factors such as results of follow-up procedures, customer payment trends including subsequent payments and customers' financial positions. If the financial conditions of the customers of the Group were to deteriorate, resulting in an impairment of their ability to make payments, additional allowances may be required. The final outcome of the recoverability of these receivables will impact the amount of impairment required.

(c) Income taxes and deferred taxation

The Group is subject to income taxes in Hong Kong. Significant judgement is required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

Deferred income tax assets relating to certain temporary differences and tax losses are recognised when management considers it is probable that future taxable profit will be available against which the temporary differences or tax losses can be utilised. Where the expectations are different from the original estimates, such differences will impact the recognition of deferred income tax assets and income tax expense in the period in which such estimate is changed.

(b) 貿易應收款項及應收票據減值

管理層根據客戶的信貸記錄及按業務分 部劃分的現行市況釐定貿易應收款項及 應收票據的減值撥備。在評估每名客戶 的應收款項可收回性時,會進行重大判 斷。在進行判斷時,管理層會考一系列 因素,如跟進程序的結果、客戶的付款 趨勢(包括期後付款)及客戶的財務狀 況。倘本集團客戶的財務狀況轉差而削 弱其付款能力,則可能需要作出額外撥 備。該等應收款項能否收回的最終結果 將對所需的減值金額造成影響。

(c) 所得税及遞延税項

本集團須繳納香港所得税。在釐定所得 税的撥備時須作出重大判斷。多項交易 及計算方式均會導致未能確定最終所定 税項。本集團根據對額外税項會否到 期的估算,確認預計税項審計事宜的負 債。倘該等事宜的最終税項結果與最初 錄得的款項有所差異,有關差額將會對 作出該釐定期間的即期及遞延所得税資 產及負債造成影響。
